(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

## **WHEREAS:**

- A)** First Party is a Higher Educational Institution named, **Wavoo Wajeetha Women's College of Arts and Science, Kayalpatnam**
- B)** Second Party is a Higher Educational Institution named, **Aditanar College of Arts and Science College, Virapandianpatnam**
- C)** First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their department resources and provide each of them with enhanced opportunities.
- D)** The Parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education, Expert Lecture, Library, Seminar, Workshop, Conference.



**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERE TO AGREE AS FOLLOWS: CLAUSE 1 CO-OPERATION**

Both Parties are united by common interests and objectives, and they shall establish cooperation.

First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.

The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

**CLAUSE 2 SCOPE OF THE MoU**

**Staff and Student exchange Program, Training, Seminars, Workshop and Guest Lectures,** - Second Party and the First Party to extend the necessary support to conduct training, seminars, workshops and guest lectures to the students of the First Party and the Second Party respectively on the technology trends and in-house requirements.

**To Jointly carry out Research and Consultancy** - A dedicated team from Department of Business Administration, Wavoo Wajeeha Women's College of Arts and Science and Department of Business Administration, Aditanar College of Arts and Science College, engage in research and consultancy services to support industries.

**To jointly engage in Curriculum & Syllabi development for Add on & Extra Credit Courses** - Both parties support to the other party in framing curriculum & syllabi for courses, where fits.



### CLAUSE 3 VALIDITY

This MoU will come into effect from the date of signing and will remain in force for a period of 2 (Two) years which is extendable by mutual consent. However, the validity of the MoU shall be terminated by mutual agreement between the parties any time during the pendency of the agreement.


### CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that the First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.


