Recitals

a. Wavoo Wajeeha Women's College is a self-financing rural based Women Minority Institute affiliated to Manonmanian Sundaranar University, Tirunelveli, providing education in the area of Arts and Science. WAJEEHA SKILL ACADEMY was established in the year 2012 offering skill based entrepreneurial courses to the students of the college which falls within the range of potential employability skills requirement.

Technology Solutions Private Limited is in the business of IT based Solutions and corporate training.

The purpose of this M.O.U is with reference to exploring the areas of co-operation benefiting the Institute and The Industry.

Areas of Co-operation.

1. To impart training to students, staff, Alumnae and faculties of the Institution by the Industry.
2. To facilitate regular interaction between the faculty and students of the institute and the workforce of the industry based on mutual convenience.
3. Industry to provide inputs to our Skill Development courses run by the institute on need basis.
4. Hands-on experience through Internships with stipend, in a real time work environment either at CODA Technology Solutions Private Limited or at WAVOO WAJEEHA WOMEN'S COLLEGE.
5. To Sponsor joint or co-operative programmes which shall include Industrial visits and for providing Technical Personnel to impart knowledge to the students.
6. To participate in and / or sponsor Conferences, Symposia, Workshops and other joint meetings of mutual interest.
7. The institute and the industry shall explore the possibilities of mutual support in their learning, hiring and research requirements based on mutual convenience.
8. Confidentiality: Each party shall maintain complete confidentiality of any information of the other, disclosed during the term of this M.O.U.
9. In no event shall either party be liable for any indirect, incidental, special, consequential damages, including, but not limited to, loss of profits, revenue, data or use, incurred by the other party in connection with, arising out of or under this M.O.U. save for any such loss suffered resulting from any wilful and grossly negligent act or omission of either of the parties.
10. Neither this M.O.U., nor any activities described herein, shall be construed as creating a partnership, joint venture, agency or other such relationship. Both parties agree that this M.O.U. represents a nonexclusive relationship between the parties and nothing contained herein shall preclude either party from participating/initiating similar relationship with third parties.
11. This M.O.U may not be amended without the prior written / email consent of both the parties.
12. This M.O.U will be effective for three years from 26.07.2022. This agreement can be renewed based on mutual convenience.
13. Termination: Either party can cancel or terminate this Agreement unilaterally (and without reason), by giving an advance written notice of one month to the other.
14. Indemnity: Each of the parties shall defend, indemnify and hold the other party harmless from and against any claim, liability, loss, costs or expenses (including reasonable legal fees) arising out of or resulting from the material breach of the provisions herein.
